



This Statement is the responsibility of the Company's management and has been approved by the Board of Directors in their meeting held on 31 January 2017. Our responsibility is to issue a report on the Statement based on our review.



Financial results for all the periods presented have been prepared in accordance with the recognition and measurement principles of Ind AS 34.
3. During the previous year, the Company had sold its Perungudi Fixed Assets for a consideration of Rs. 537.86 Crores. The Profit of Rs. 535.34 Crores was disclosed as an exceptional item in the Statement of Profit and Loss for the year ended 31 March 2016.
4. As the Company's business activity falls within a single segment viz. 'Paints' and the sales substantially being in the domestic market, the disclosure requirements of Ind AS 108 - Operating Segments are not applicable.
